Capitalized terms used but not otherwise defined herein have the meanings given to such term in the terms and conditions (the "Terms and Conditions") of the Notes.

Pursuant to § 4.1(b)(ii) and (iii) (*Payment of Interest / PIK Toggle*) and § 14 (*Notices*) of the Terms and Conditions, Accentro Real Estate AG as issuer of the Notes, hereby elects to pay in kind, and not in cash, the full amount of interest accrued and due on December 31, 2025 in respect of the Outstanding Reinstated 2029 Senior Secured Principal Amount by increasing the Outstanding Reinstated 2029 Senior Secured Principal Amount of the Notes (the "Reinstated 2029 Senior Secured Principal PIK Interest Payment").

Pursuant to § 4.1(b)(iii) of the Terms and Conditions, the Issuer hereby announces that the Outstanding Reinstated 2029 Senior Secured Principal Amount of each Note will be increased by EUR 362,29 on December 31, 2025 to EUR 35,081.34. Following such increase, the total Outstanding 2029 Senior Secured Principal Amount of all Notes will accordingly be EUR 35,081,332.25.

Pursuant to § 4.1(b)(vi) of the Terms and Conditions, the increase of the Outstanding Reinstated 2029 Senior Secured Principal Amount will become effective on December 31, 2025, and such payment shall be reflected by use of a pool factor in compliance with the requirements and procedures of the Clearing System pursuant to § 4.1(b)(v) of the Terms and Conditions.
